Having led the country for 22 years, with a career that spanned decades, Tun Dr Mahathir Mohammad is a brilliant politician. Dr M: Where's the pride in grads selling nasi lemak, driving Uber?



KUALA LUMPUR, Jan 17 — Tertiary graduates earning a living by becoming nosi lemak sellers or ride-sharing drivers is a sign the country does not have enough high-income jobs and not something to boast about. Tun Dr Mahathir Mohamad said today.

The former prime minister said such developments suggested that Malaysians were now struggling to get by with just a single job, rather than any indicator of growing entrepreneurship.

"We cannot be proud of those involved in selling nasi lemak or becoming Uber drivers. This is for them to sustain their income as they have no income sources," he said during his second Policy Talk session broadcast "live" on his official Facebook account.

Just for the sake of lampooning the Barisan Nasional federal government, Tun Dr Mahathir Mohammad disdainfully declared that it is an "embarrassment" that nation's graduates need to sell nasi lemak or become Uber drivers to make ends meet. He claimed that it indicated the government's failure in ensuring university graduates are employed in jobs with salaries matching their ability levels.

Even before he became Prime Minister for 22 years, Dr Mahathir was Minister of Education. He was very much involved in policy formulation, and if our education standards have declined, he and his protégé Dato' Seri Anwar Ibrahim bear more responsibility than the current BN government he accuses of.

Going by his same logic, then Dr Mahathir as a trained medical physician should have kept to his medical practice, rather than venturing into politics.

Dr Mahathir should not deny that during the 1998 financial crisis, many fresh graduates who returned from overseas or had graduated locally had difficulty securing their jobs befitting their degrees. With job cuts, graduates would accept clerical jobs whilst applying for better positions elsewhere. It was not unusual for Masters holders to apply for diploma level jobs or even basic secretarial, administrative posts.

Is it not meaningful that graduates become part time hawkers or ride-sharing drivers which are an honest means of earning a living whilst searching for a job, or awaiting placement in the civil service? This is an experience-learning opportunity on entrepreneurial skills, interacting with the public, handling human relations, rather than narcotics addition, armed robbery,

KUALA LUMPUR, June 13 -- Tun Dr Mahathir Mohamad said today that there were no basic qualifications to become a prime minister, pointing out that he used to fry and sell banana

The country's longest-serving prime minister who trained as a doctor, said even an "office boy" needs an SPM qualification, while politicians have the "easiest job" as they are not required to have any academic qualifications.

Let's be frank. So many people be they young or old have a tendency to snap photos of whatever they eat — be it street delicacies or fine dining. Therefore, to entice tastebuds, or attract more customers, a nasi lemak or burger flipping vendor would present their meals in a more creative way, or try different ingredients and marination.

Let us not deny that the business of some hawkers are so successful that they are able to provide tertiary education to their offsprings be it locally or abroad. Likewise there is a trend among youngsters and graduates these days to delve the foodtruck business and expand into franchising.

What is important is that these food and beverage traders maintain hygiene and nutrition standards, and preferably, if possible, obtained licence from local authorities.

It is common these days for graduates to pursue careers distinct from what they studied eg a law degree holder may end up as a journalist, or a dentist may find the restaurant industry more fulfilling, or an auditor may end up owning a chain of restaurants.

Attaining a basic degree provides a fresh graduate a head start on the starting salary. But this does not mean adults who lack a Bachelor's degree, and only hold a diploma or certification in vocational skills or have many years of working experience are no less talented, or are disabled from earning an income, compatible if not higher than that of a fresh graduate.

Then there is also the debate of street smart vs book smart, but let's keep that debate for another day!

The Malaysian Constitution – Article 153

Legitimate Interests of Other Communities



Whilst safeguarding the special position of bumiputras, the Yang di-Pertuan Agong (YDPA) is also responsible for safeguarding the "legitimate interests" of other communities in accordance with Art. 153, which provides that:



The YDPA has the responsibility safeguarding of the legitimate interests of other communities in accordance

with Art. 153:

Parliament may not restrict any business or trade solely for bumiputras

Civil servants must be treated impartially regardless of race

Article 153 cannot deprive any person of any public office already held by such person

No person may be deprived of any federal scholarship etc. already enjoyed by such person

Laws reserving quotas in trade licences and permits may not deprive any person of any right, privilege, permit or licence already enjoyed or held by him or authorise a refusal to renew such person's license or permit

The Rise of the Ummah Convention struck a raw nerve when Datuk Raof Husin, representing the Malaysian Association of Former Education Officers, erroneously Art. 153 – Legitimate interests of other Communities asserted that the government was constitutionally bound to limit study aid to Bumiputra students. Even worse was when race extremist group Perkasa led by its Deputy President Sirajuddin Salleh, in support of Raof raised the spectre of the May 13 riots to justify that scholarships should be limited to Malays only (Malay Mail Online, 16 Jan 2018), adding that "those who are opposed to scholarships for Bumiputera as those who are anti-national unity and at the same time wish to see the country's destruction."

> Considering that Perkasa members had made a huge fanfare of them joining PKR and Parti Pribumi Bersatu Malaysia, and that its patron and founder is Tun Dr Mahathir Mohammad, Malaysia's longest serving premier who is the Prime Minister designate of Pakatan Harapan, PH partners, especially so-called Malaysian Malaysia DAP must come out to repudiate such racist exhortations.

> Or, to curry favours with Perkasa and Dr Mahathir, and to still try to secure non-Malay ballots especially from rural areas, does the Rocket's silence on this divisive and inflammatory issue equate to supporting denying meritorious non-Malays access to government scholarships?

What exactly does Article 15 "The Yang di-Pertuan Agong shall exercise his functions under this Constitution and federal law in such manner as may be necessary to safeguard the special provision of the Malays and natives of any of the States of Sabah and Sarawak and

to ensure the reservation for Malays and natives of any of the States of Sabah and Sarawak of such proportion as he may deem reasonable of positions in the public service (other than the public service of a State) and of scholarships, exhibitions and other similar educational or training privileges or special facilities given or accorded by the Federal Government."

The said provision is qualified whereby specific assistance are rendered to the Malays and natives only on a proportion that the Yang Di Pertuan Ágong deems reasonable.

Perkasa and the Ummah Convention must abide with Article 153(7) which reads:

"NOTHING in this Article shall operate to DEPRIVE or authorise the deprivation of any person of any right, privilege, permit or licence ..."


While according the Malays and the natives of Sabah and Sarawak a special position, this special position is a privilege. Article 153 never intended to automatically permit or authorise wholescale discrimination (institutionalised or otherwise) against ethnic minorities as a right.

It is important that equal opportunities should be given to all communities to attain a high level of education and eradicate poverty. MCA always focuses on education, which guarantees our future to bring us out of poverty as well as tap talents.

RM6.3bil Penang Undersea Tunnel SCANDAL

Prioritising developers of luxury condominiums above common residents' concerns



In response to the wave of ups and downs on the Penang undersea tunnel issue, Penang Chief Minister Lim Guan Eng only has three types of responses – mischievous, evasion of responsibility, and media incrimination.



Guan Eng admitted that the state government had a land swap deal for 3 highways, asserting that "not a single sen was paid." Today, the contractor of undersea tunnel has already constructed a luxury apartment on the prime seafront land and made it available for sale in the market. However, the three highways project has lagged behind for more than three years.

What is even more outrageous is that this luxury apartment development previously faced collective complaints from more than 100 residents in the area and was been suspended by the Penang State Appeals Board. However, MBPP appealed on behalf of the developers but lost the lawsuit in April 2016 and was ordered to pay the Appeals Board and residents RM35,000.

Meanwhile, why did the SPV commence a joint venture with another listed company and gained booking profits from property development projects worth RM800 million and RM15 billion on state land, which is part of the payment paid or to be paid by the state government for the tunnel project, although the construction for any of the components of the project has not even started yet?

In 2015, the joint venture proposed a planning permission to MBPP. Why did MBPP approve the application in only 8 days? And MBPP had also approved to increase the development density from the original 30 units per acre to 156 units.

When MCA Deputy President Datuk Seri Dr Wee Ka Siong revealed a local fashion company which has been running at a loss is a shareholder of a special purpose vehicle (SPV) for the undersea tunnel project (the company had a cash balance of RM1.7 million and short-term loans of RM16.5 million, how will it be able to undertake the complicated RM6.3bil project?), Guan Eng retorted "the Minister of Finance acquired a 51% stake in TRX, can MoF develop The Exchange 106 skyscraper?" This again reveals a rogue-style irrelevant answer.

In a move to reassure the public, besides the Penang state government publication *Buletin Mutiara* on 4 Mar 2013 and CM Guan Eng's open letter in the newsletter's 16~31 Mar 2013 edition, Guan Eng's reply in the Penang state Legislative Assembly on 29 Nov 2013 conveyed that the SPV which was awarded the mega project included China construction giants China Railway Construction Corporation Ltd and Beijing Urban Construction Group. Both these firms are renowned for constructing the Qinghai-Tibet Railway Line and the Beijing Olympics Bird's Nest Stadium respectively. The SPV was backed collectively by a RM4.5bil in paid-up capital.

However, 5 years later, the feasibility study reports are not even completed.





BN Supreme Council:
MCA reached a consensus so that govt doesn't table proposed amendments to Act 355

On 7 Apr 2017, the last of day of the first quarter of 2017's parliamentary session, the Dewan Rakyat Speaker suddenly allowed PAS President Dato' Seri Hadi Awang to table the Private Member's Bill on proposed amendments to the Syariah Courts (Criminal Jurisdiction) Act or Act 355 despite strong objections from MCA.

During the Barisan Nasional Supreme Council Meeting on 29 March, MCA reached a consensus with the government to not table the Act 355 Bill. The Bill remained as the Private Member's Bill by Hadi Awang.

After the BN Supreme Council announced that the government would not table the proposed amendments to Act 355 as a government Bill, the Dewan Rakyat Speaker used his power to allow Hadi to table his Bill. The Speaker also announced the adjournment of the parliamentary session after the tabling.

MCA backbenchers Dato' Koh Nai Kwong and Dato' Khoo Soo Seang stood up to intervene during the tabling of the Bill, stressing and explaining MCA's objection against the Bill. They also raised that the Bill was unconstitutional and violated the principle of "all men are equal before the law."

10+6 SJKC Plan: Major breakthrough for Chinese Education

TOTO SJK

On 26 Oct 2017, the government announced the construction of 10 new SJKCs and 6 relocated SJKCs. From 1999 to 2017, the government built a total of 29 new and relocated 98 SJKCs respectively, totalling 127 SJKCs. This is a major breakthrough for Chinese education in our country, which mainly reflects:


- (i) The first time our government has approved the construction of such a huge number of SJKCs.
- (ii) The total number of SJKCs has increased to 1,398 nationwide. The number of SJKCs exceed the benchmark of 1,300.
- (iii) Among the 10 new SJKCs, some will be built in emerging development zones, in preparation for the expected population growth in the future. This also means that the construction of SJKCs is planned based on demand, rather than just for an area's emergency needs.

Party Constitution amended to enhance participation of youth & women

Following amendments to the party Constitution to enhance the participation of grassroots members last year, MCA convened an Extraordinary General Assembly (EGM) in March 2017, and once again, amended the party Constitution. This move enables divisional/branch Youth and Wanita chairman to automatically become central/divisional delegates respectively, as well as reserving a division/branch seat for Wanita MCA leaders whose age does not exceed 40 years.

This is an important part of MCA's transformation plan: ie to strengthen party democracy. The participation of more females and youths will make the party younger and more representative.

This amendment to the party Constitution also sees the appointment of all Vice Presidents into the Presidential Council. A new clause was inserted to enable the establishment of the MCA School of Political Studies to be a permanent feature.







In conjunction with the nation's 60th year of Independence, MCA set up a National Day celebration working committee. Headed by MCA Deputy President Datuk Seri Dr Ir Wee Ka Siong, a series of patriotic activities themed 'Malaysia, My Country, My Home' were launched from April 2017.

The working committee organised more than 10 events, including 'Trends & Challenges of Chinese Malaysian Population', 'Glorious Malaysia Because of You: Malaysian Chinese Women Excellence Award', 'ThumbsUp4MY campaign', 'MCA Youth Amazing Rail & Walk a Hunt', 'Patriotic Palm Print Mural Painting', '2nd Blossom Arts Festival Malaysia 2017', 'Launching of MCA Special Badge in Conjunction with Hari Kemerdekaan 2017' and many more. All these activities provide a platform for the Malaysian Chinese to showcase their patriotism.

The 'Patriotic Palm Print Mural Printing' successfully attracted 82,126 participants, while 'ThumbsUp4MY campaign' collected 66,916 thumbprints in total, thereby entering into the Malaysia Book of Records.

Chen Wing Sum was the hero behind the establishment of diplomatic relations between China and Malaysia. He also served as Minister of Housing, Local Government and New Villages. In 1971, he led a Malaysian delegation to the Asia, Africa and Latin America ping pong tournament in Beijing, and was directed by the then Prime Minister Tun Abdul Razak to establish diplomatic ties with China.



I was almost in tears reading the press release version of the Federal Court judgement of 29 Jan 2018. Justice has long been denied to Indira Gandhi due to the inordinate delay of her case. A family's misfortune became the object of numerous tugs of war amongst the many self-assuming actors.

I met Indira when holding a watching brief with my Task Force Deputy Datuk Koo Chin Nam for MCA at the Ipoh High Court 4 years ago. We addressed the High Court then on the historical facts when the Federal Constitution was drafted vis~a~vis the ingenious attempted distortion of historical truth in construing the Federal Constitution by some quarters.



Key thrusts of the landmark Federal Court's decision

The Apex Court makes it abundantly clear:

- Article 121(1A) does not oust the jurisdiction of the civil courts, nor does it confer judicial powers to the Syariah courts.
- 2 As the Syariah court cannot hear a non-Muslim's application, the civil court has jurisdiction
- Only the civil court has jurisdiction on matters involving the review of any administrative (executive) action including by religious authorities.
- The civil court is the final arbiter of laws, its jurisdiction can never be ousted by Parliament by way of constitutional amendment.
- No amendment of Federal Constitution and federal laws can deprive the judiciary's judicial power, as that is the Basic Structure upon which our beloved Nation Is Built!
- Interpretation of "parent" in Article 12(4) is taken to mean BOTH parents and not either one can determine the minor child's religion as the 2007 Federal Court ruled
- President of the Federal Court Justice Zulkifli Makanudin announced on behalf of the court: "in deciding the issue before us, as judges, we are not swayed by our own religious conviction and sentiments over the issue."

What is needed now?



The Attorney General Chambers should table the dropped Section 88A into the Law Reform (Marriage & Divorce)
Bill to legislate clearly that when one spouse embraces Islam:

- Permission is required by BOTH mother and father to convert their minor children to Islam.
- In cases of dispute, the religion of the minor child shall REMAIN the religion of the parents at the time their marriage was registered.
- The child may choose his/her own religion upon attaining 18 years.
- The physical presence of both parents with non-Muslim witnesses must be required at religious departments if a minor child is to utter the Kalimah Shahadah (affirmation of faith)
